Water, Sanitation, and Hygiene

10,613 men, women, and children were trained on critical water safety and sanitation practices; **855** sanitation facilities like toilets and latrines were constructed; and **111** clean water provisions were built – including boreholes, wells, water points, and rain water harvesting tanks.



Health and Nutrition

262,980 children received de-worming and anti-parasitic medication; **19,330** daily meals or nutritional supplements were provided; **45,581** children received basic medical care; and **70,205** youth participated in HIV/AIDS prevention programs.



Education

165 classrooms and libraries were built or enhanced; **66,088** children received the necessary school fees, supplies, textbooks, and uniforms to attend class; and **4,840** teachers and volunteers upgraded their training in important teaching techniques, like 'Learning through Play' and early childhood education.



Sustainable Livelihood Development

4,487 individual micro-credit business loans were distributed; **5,460** parents received essential accounting, bookkeeping, and basic business skills training; and **2,464** men, women, and youth participated in a specific vocational training program.

Strengthening Community Organizations

14 programs and communities reached a level of sustainability high enough to be graduated from CCFC programming; **9,890** parents and children were trained to be community group leaders – groups designed to maintain and improve living conditions at the grassroots level; **29** emergency response teams were established; and **379** community leaders were trained in natural disaster emergency response protocol.



Child Rights and Protection

426 houses were built or significantly improved, providing essential shelter to children; **8,158** men, women, and children were educated on the importance of basic human rights for children, such as a child's right to an education and the dangers of child labour; and **24,455** children participated in extra curricular activities, offering them a fun, safe, and supervised alternative after school.

Gender Issues and Rights Awareness

3,134 women received small business loans in order for them to develop an independent, sustainable income; **682** mosquito nets were supplied to young and pregnant women – one of the most vulnerable populations to contract malaria; **266** midwives and birth attendants were educated in safe, hygienic birthing practices; and **1,853** men, women, and children were educated on gender rights.



Environment

15,266 fruit and nut trees were planted, benefitting not only the environment but increasing a community's nutritional and economic status; **1,128** community gardens were established; and **3,634** community members were educated on critical environmental issues like soil erosion and conservation, deforestation, and recycling.
